#### Letter from the Executive Board

#### **Dear Delegates**

Secondly, this Committee is stimulated for the first time but we expect that the Delegates representing will come researched and well informed of the discussion on the controversies and problems that has happened in the past, and have knowledge of the decisions which were taken. If you are well researched and versed in your team's policy, be creative with your solutions, and be proactive! Never be afraid to suggest something out of the box, because it is going to be discussed by your peers if you can lobby. Do not be afraid of being wrong, because the best experience of being a Delegate at an MUN Conference is completely giving in to become that person and feel their responsibility and dedication to representing their nations. Your Executive Board is here to guide debate, and will be taking part in substantive debate only through the updates and questions to you. We will refrain from giving our opinion on matters unless we are ruling on Points of Orders. Regarding Rules of Procedure, I would ask you to be conversant in them but not regard them as strict and unbreakable. Rules of Procedure were made to aid debate, not hamper it, so we would like to keep the Points of Orders for usage of personal pronouns to a minimum. Further, we would love for the delegates to converse amongst themselves and promptly let the Executive Board know if they wish for any rules to be amended to improve debate.

#### How to read the Document

3. Understanding the Policy of the allotted team by studying past actions, their causes and consequences

4. Reading the document

5. Researching further upon the issues using the footnotes

6. Prepare topics for moderated caucuses and their content

7. Assemble proof/evidence for any important piece of information/allegation you are going to use in committee

8. Keep your research updated.

#### History of the Committee

#### IPL 1

• Mumbai Indians' stand-in captain Harbhajan Singh slaps Kings XI Punjab's S Sreesanth after losing a match in Mohali. A sobbing Sreesanth is caught on camera. After investigations, BCCI hands Harbhajan an 11-match suspension. Sreesanth rakes up the issue in the ongoing edition only to be reprimanded.

- Conflicts with the England and Wales Cricket Board
- Media restrictions

## IPL 2

- Shifted to South Africa due to general elections, the second edition is marred by allegations of Foreign Exchange violations. The Enforcement Directorate one year later issues 'Red Corner' in the name of former IPL commissioner Modi
- Conflict with Cricket Club of India
- Kings XI co-owner Mohit Burman is beaten up by security guards on allegations of improper behaviour with a lady spectator, belonging to an influential industrialists' family in South Africa.
- Shah Rukh Khan and John Buchanan's decision of 'Multiple Captaincy' creates rifts in KKR team with anonymous blogger 'Fake IPL Player' creating a flutter. Later the blogger reveals his identity and claims that everything in his blog was fictional.

## IPL 3

- The BCCI suspends Modi for misappropriation of funds.
- Junior foreign minister Shashi Tharoor resigns from his post after investigations reveals his role in bringing Kochi Tuskers Kerala on board with his then girlfriend Sunanda Pushkar also involved in dealings.
- Chirayu Amin named IPL interim chairman and the missing documents.

#### IPL 4

- Before the start of tournament, Manish Pandey is banned by IPL governing Council for four matches as he indulges in underhand dealings with franchises -- he would have got a fixed sum being an uncapped domestic Indian player.
- Post fourth edition, Kochi Tuskers Kerala are scrapped from the tournament, after they fail to pay the franchise fees. There were discrepancies found out in their ownership patterns.

#### IPL 5

• Pune Warriors threatens to pull-out of IPL.

- During IPL, RCB cricketer Luke Pomersbach arrested by police for harassing NRI woman Zohal Hameed and bashing up his boyfriend. Dispute settled out of court.
- Spot Fixing Case.
- Pune players Rahul Sharma and Wayne Parnell caught in a rave party in Mumbai.
- Deccan Chargers scrapped from IPL after they fail to pay up franchisee fee to the BCCI.

#### IPL 6

- Spot Fixing and Betting Case.
- Pune Warriors withdrawal

#### IPL 7

• Kieron Pollard and Mitchell Starc spat.

#### IPL 8

- The ED in May summoned Kolkata Knight Riders (KKR) co-owners Bollywood superstar Shah Rukh Khan, actress Juhi Chawla and her husband Jay Mehta. KKR is suspected to have violated Foreign Exchange Management Act (FEMA) norms by under valuing its shares in a transfer deal with Mehta's overseas company, Sea Island Investments Ltd.
- Known for his power hitting, Knights' opener Robin Uthappa came under fire after he allegedly held Royal Challengers Bangalore (RCB) youngster Sarfaraz Khan "by the collar". While match referee Javagal Srinath denied receiving any complaint, Gambhir called it "not a major issue" and which "happens with a lot of people".
- RCB skipper Virat Kohli, who was in the news for a heated argument with umpire Kumar Dharmasena during a match against Sunrisers Hyderabad, was found guilty of breaching the ACSU protocol by meeting his girlfriend Anushka Sharma during a match against Delhi Daredevils.
- One of the most popular and successful IPL franchise, the Mahendra Singh Dhoni-led Chennai Super Kings (CSK), found themselves under the

Enforcement Directorate (ED) scanner when the agency sought details regarding the undervaluation of the franchise.

• Modi made a sensational claim that at least four CSK players were involved in match fixing. Referring to the Justice Mudgal Committee which has submitted its report on IPL spot fixing to the Supreme Court, Modi earlier in the month tweeted: "So here is my BREAKING STORY - IF THE #HONORABLE #SUPREME #COURT WAS TO REVEAL THE NAMES OF PLAYERS INVOLVED IN FIXING - at least 4 are CSK." Modi also claimed that "9,000- 10,000 crore of rupees per game" was being cast as bets in the IPL.

#### Present Scenario

A day after the owners of the Chennai Super Kings and Rajasthan Royals franchises were suspended for two years by a Supreme Court-appointed panel, BCCI and IPL team officials had discussions across the country to try and figure out a way forward.

IPL chairman Rajeev Shukla met with BCCI president Jagmohan Dalmiya in Kolkata to discuss the implications of the Lodha Committee's order, and the Super Kings top management huddled with legal experts in Chennai around the same time. Royals remained tightlipped about their plans for a second day running, but word in the BCCI was that the franchise had no option but to appeal.

While Shukla was sure that "IPL-9 will take place", former IPL vice-chairman Niranjan Shah said a special general body meeting was the need of the hour instead of an IPL governing council meeting.

The question which arises is that <u>Where will the IPL</u> <u>go from here?</u>

- Should The BCCI Invite bids for two new teams for two years and would these be an appropriate option?
- Should The BCCI Invite bids for two new teams for a longer duration?
- Should there be a 6 team IPL from now on knowing that it will be not commercially viable for BCCI?
- Should The BCCI itself runs two teams for two years?
- Should IPL be suspended for 2 years?
- Should The BCCI now remove ban on the players on whom the charges are removed from the court or they should go for looking more evidence to prove them guilty?
- Should The BCCI reform their IPL governing structure after seeing these things?
